The WhatsApp Groups reportedly have more than 90 members with multiple Group Admins attached to them, with such Admin contacts fraudulently bearing photos of one of our employee with phone numbers 6355560800, 9234443580, 9258188942, 7856814863, 9135910464 not belonging to him/her.

Apart from the aforesaid WhatsApp Groups and Mobile numbers, these impostors may be using other channel(s) / platform(s) / mobile number(s) that we are not aware of.

In order to caution the public in general, we would like to inform that Abans Group and its employees and Directors are in no way associated with these fraudulent social media accounts / posts / WhatsApp groups / Mobile numbers and shall not accept responsibility or liability whatsoever for any loss / damages of any kind arising out of the use of or reliance on any information contained on such WhatsApp groups, and/ or any other channel / platform which we are not aware of.

We request you to note that such WhatsApp groups are not authorized by Abans Group, nor do we operate or endorse any WhatsApp groups for advisory services. Further, if you come across any groups or individuals claiming to be associated with Abans Group on WhatsApp or other social media platforms, please treat them as fraudulent and report them to us immediately on info@abans.co.in
